



Announcement of Saimai District Office

Subject: Anti – Bribery Policy

Reference is made to Strategic Sub-issue No. 5.4 on a transparent city under Strategic Issue No. 5 on promoting the creation of a participatory democratic city of the revised 20-Year Development Plan for Bangkok Metropolis (B.E. 2561-2580); Goal No. 5.4.2 in having efficient disciplinary implementing system relating to malfeasance and corruption and mechanism for preventing malfeasance and corruption in the future of the Strategic Sub-issue No 5.4 on a transparent city under Strategy No 5 on promoting the creation of a participatory democratic city of the 20-year Development Plan for Bangkok Metropolis Phase 3 (B.E. 2023-2027) and the policy of “being transparent, saying no to bribery” of the Governor of Bangkok (Mr. Chadchart Sittipunt).

Saimai District Office has seen the importance of pushing forward actions against bribery. In order to propel the Development Plan for Bangkok Metropolis and the Governor of Bangkok’s policy for preventing corruption and misconduct and bring about concrete result that Saimai District office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration can observe as a guideline; therefore, the Anti-Bribery Policy shall be designated as follows;

1. Saimai District office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration shall perform their duties with integrity and honesty without being involved in demanding, providing, or taking bribes, in both direct and indirect ways, for the benefit of themselves or other persons, or the benefit of those relating to themselves or the benefit of those relating to the Bangkok Metropolitan Administration;

2. Saimai District Office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration are prohibited from taking bribes in operating all kinds of procurements. The procurement shall be performed with transparency, integrity, and accountability under related laws and regulation;

3. Saimai

Saimai District office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration shall not offer to do, promise to do, or receive and other property of benefit from private sectors or and other persons so as to induce such person to do or not to do any act or to delay the doing of any act with malfeasance;

4. Any Saimai District Office civil officials and personnel as well as persons who perform other duties in agencies under Saimai District Office seeing any acts being probable of bribery shall make an immediate report to superiors or via complaint channels and has a duty to inform all outsiders about the Policy.

5. Superiors shall control and follow up to have the observance of this Policy Once aware of violation or non-compliance, superiors who have authority shall seriously take disciplinary actions and criminal cases.

6. Any actions under this Policy shall follow the designated guideline as well as other ones deemed suitably regulated by Saimai District Office afterward to comply with this Policy.

Saimai District Office has seen the importance of pushing forward actions against bribery. In order to propel the Development Plan for Bangkok Metropolis and the Governor of Bangkok’s policy for preventing corruption and misconduct and bring about concrete result that Saimai District office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration can observe as a guideline; therefore, the Anti-Bribery Policy shall be designated as follows;

1. Saimai District office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration shall perform their duties with integrity and honesty without being involved in demanding, providing, or taking bribes, in both direct and indirect ways, for the benefit of themselves or other persons, or the benefit of those relating to themselves or the benefit of those relating to the Bangkok Metropolitan Administration;

2. Saimai District Office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration are prohibited from taking bribes in operating all kinds of procurements. The procurement shall be performed with transparency, integrity, and accountability under related laws and regulation;

3. Saimai

Saimai District office civil officials and personnel as well as persons who perform other duties in agencies under the Bangkok Metropolitan Administration shall not offer to do, promise to do, or receive and other property of benefit from private sectors or and other persons so as to induce such person to do or not to do any act or to delay the doing of any act with malfeasance;

4. Any Saimai District Office civil officials and personnel as well as persons who perform other duties in agencies under Saimai District Office seeing any acts being probable of bribery shall make an immediate report to superiors or via complaint channels and has a duty to inform all outsiders about the Policy.

5. Superiors shall control and follow up to have the observance of this Policy Once aware of violation or non-compliance, superiors who have authority shall seriously take disciplinary actions and criminal cases.

6. Any actions under this Policy shall follow the designated guideline as well as other ones deemed suitably regulated by Saimai District Office afterward to comply with this Policy.
