



Announcement of Huai Khwang District Office

Subject : Declaration of Intent on Public Administration Integrity and transparency policy

According to the intent of the Constitution of the Kingdom of Thailand, B.E. 2560, Official Information Act. B.E. 2540, the Royal Decree on Criteria and Procedures for Good Governance, B.E. 2546, National Anti-Corruption Strategy Phase 3 (B.E. 2560 - 2564) and the current Royal Thai Government's policy statement number 12 on prevention and suppression of the corruption and misconduct as well as judicial system and legal channels, there are provisions of measures and innovative technology systems to prevent and reduce corruption and misconduct strictly and seriously. All these are systematic monitoring tools for evaluating corruption and misconduct problems and solutions, accelerating awareness raising among the general public to adhere to honesty, trustworthiness, correctness, and righteousness, and encouraging all sectors to be involved in the prevention and monitoring of corruption and misconduct.

The Cabinet Resolution on 23 January B.E. 2561 required all government agencies to cooperate and participate in Integrity and Transparency Assessment (ITA) in the fiscal year B.E. 2561 - 2564 using the guidelines and assessment tools as prescribed by the Office of the National Anti-Corruption Commission (NACC) and heads of departments/ government agencies to give the importance to the assessment of integrity and transparency of government agencies and use the evaluation results to strictly improve government agencies' integrity and transparency.

In order to drive the above-mentioned National Strategy to successfully yield concrete outcomes, Huai Khwang District Office hereby issued the Declaration of Intent on Public Administration with Integrity and Transparency which shall be used as standards, guidelines, and shared values for government officials and organization personnel to adhere to and practice together with other related rules, regulations, and obligations with determination to guide Huai Khwang District Office to perform its missions with transparency, to carry on the administration and management with integrity, virtue and free from corruption. In order to achieve the intention, agencies under Huai Khwang District Office shall act as follows:

1. To administer and perform duties based on good governance principles:
 - To respect and comply with laws, rules and regulations without intentional violation or deliberate avoidance;
 - To uphold and believe in virtues with campaigns to create good values among the personnel such as integrity, devotion, patience, diligence and discipline;

- To disclose...

- To disclose useful information complying with the Official Information Act B.E. 2540, to have systems that allows the public to have access to information, and to improve the information system and archive storage to make it easier to search and disseminate information to the public;

- To give opportunities to government officers, personnel, and the relating public to be involved in acknowledging and expressing opinions on various matters;

- To be responsible at work. If there are any problems or deficiencies, everyone must cooperate, help each other to find solutions, be responsive, create awareness of personal responsibility and promote the personnel with high potential;

- To create awareness among government officers and personnel on energy and resource saving.

2. To cultivate values and attitudes to government officers and personnel to know, understand and uphold principles of ethics and morality as well as to apply Sufficiency Economy Philosophy as a guiding principle in living and working.

3. To promote transparency in every step of public procurement, to make public and to provide opportunities for private sectors and the general public to take part in monitoring the operation which can be done by providing news and information on activities to the public.

4. To publicize channels for giving information, providing clues for corruption, complaints and petitions and to assign officers to receive the complaints and petitions as well as to implement the related matters.

5. Any corruption found shall be investigated. If found guilty, the offenders shall be liable to serious punishment.
